None of the Sutter-Yuba Republican Assembly (SYRA) members renewed their 2017 California Republican Assembly (CRA) dues. Carla Virga, SYRA Secretary, notified Nancy Hinton, CRA Membership Secretary, via January 18, 2017, email (attached), the SYRA board members met December 30, 2016, and voted unanimously to discontinue SYRA.

No one within SYRA received a response from anyone connected with CRA.

Members of the former SYRA became members of the new Sutter-Yuba Constitutional Republicans (SYCR), a chapter of the newly chartered California Impact Republicans (CIR).

Carla Virga was informed Dennis Hudson, current CRA President, informed CRA members at their recent convention that although SYRA submitted notice to discontinue, he had spoken with SYRA members who want to continue the SYRA chapter. Carla telephoned every former SYRA member and asked each, "Have you spoken with anyone from the CRA?" Each responded, "No." She then asked, "Have you ever told anyone you want to continue the SYRA chapter?" Each replied, "No."

Today, despite the facts 1) SYRA voluntarily surrendered our charter due to the CRA's lifetime expulsions of the messengers (you and George) for exposing fraudulent CRA chapters and non-existent members; and 2) Larry Virga has not renewed his CRA membership, both SYRA and Larry Virga are still (fraudulently or erroneously) listed on the California Republican Assembly website -- <http://cragop.org/local-units>:
