Dear Stanley Sniff:

Effective immediately, the members of Service Employees International Union Local 721 (SEIU) have voted to remove their endorsement for you as the Riverside County Sheriff-Coroner.

You have failed to deliver on your promise to be fair and equitable to all employees under your command in the Riverside Sheriff's Department.

You have failed to maintain a productive and cohesive work environment in which the dignity of all workers is respected.

You have failed as the Chief Executive to ensure your subordinates honor all Federal and State laws or regulations, county policies and procedures governing employee conduct, and the provisions contained within the Memorandum of Understanding between SEIU Local 721 and Riverside County.

Our members have rendered a vote of no confidence in your ability to lead the department in a principled and fair manner. We can no longer support your efforts to serve in your current capacity.

Therefore, we are left with no choice but to ask that you remove SEIU Local 721 from all campaign literature and/or correspondences involving your efforts to seek another term as the Riverside County Sheriff-Coroner.
