Since 1991 the Orange County Transportation Authority (know as O-C-T-A) has been responsible for the continuous improvement of Orange County's transportation network and overall transportation planning including bike lanes, buses, highways, Metrolink, major roadways and the 91 Expressway, for residents and commuters moving throughout the 34 cities and unincorporated areas of Orange County. Funding for OCTA comes from tax dollars, including from Measure M2, which was approved by Orange County voters. OCTA has a board of directors made up of elected and appointed officials.

Since 1987, the Transportation Corridor Agencies (known as T-C-A) has developed and operated toll roads, including State Routes 73, 133, 241 and 261. Funding for the construction of the toll roads comes through the sale of bonds to both private individuals and institutional investors and repaid by people paying tolls. The toll roads TCA builds are supposed be turned over to the state and become free for the public to use once the debt has been paid off. TCA has two boards of directors made up of elected and appointed officials.
